# Detailed Description



## Brisas Del Este – Phase I (Norte)

Brisas Del Este – Phase I (Norte) is the second phase of new construction on the Miami Dade County Public Housing site called Three Round Towers. This facility will comprise an 8 story apartment complex of 160 affordable housing units adjacent to a parking garage that serves the entire campus. Furthermore, the ground floor of the development will host the community center that serves elderly residents of the area.

Opportunities for public art include artworks for interior lobby, community center, and / or interior courtyard, with a budget of \$320,000.00 (at least 3 commissions envisioned).

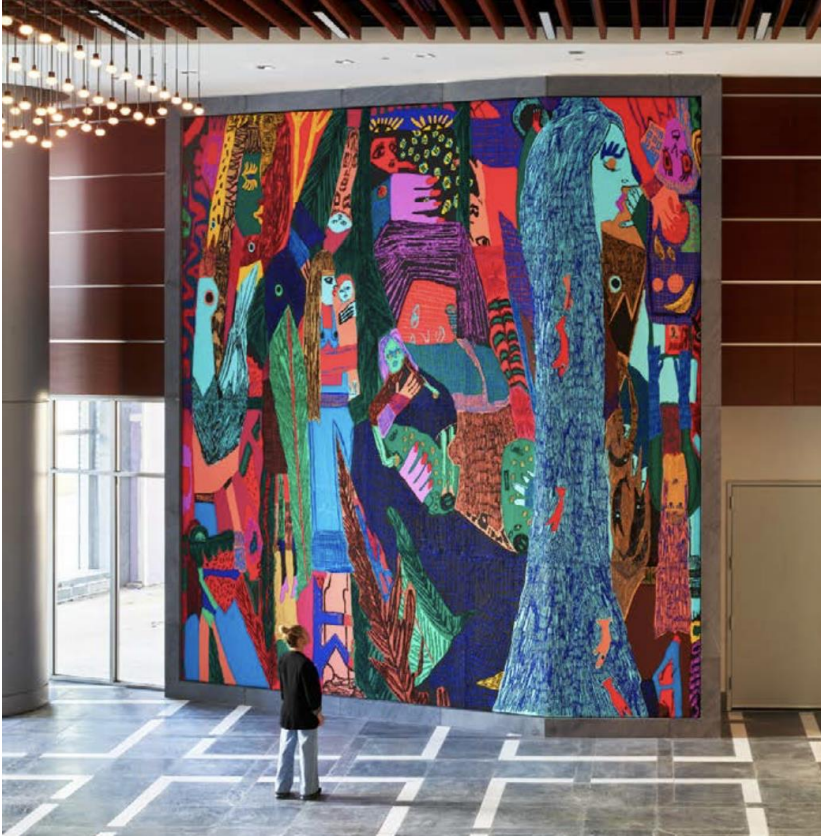


## Paseo Del Rio, River Parc

Paseo Del Rio is a housing facility within River Parc, a campus of affordable housing facilities owned and operated by Miami-Dade County and developed by Related Urban. Located beside the Miami River in the historic "Little Havana" neighborhood, River Parc encompasses existing facilities which will be incorporated within the new masterplan. It is envisioned that the campus will be unified with hardscape and site-work, including the construction of a new linear park leading from NW7th Street to curve along the Miami River.

Opportunities for public art include but are not limited to artworks for interior lobby and / or interior courtyard, with a budget of \$120,000.000 (2 commissions envisioned).

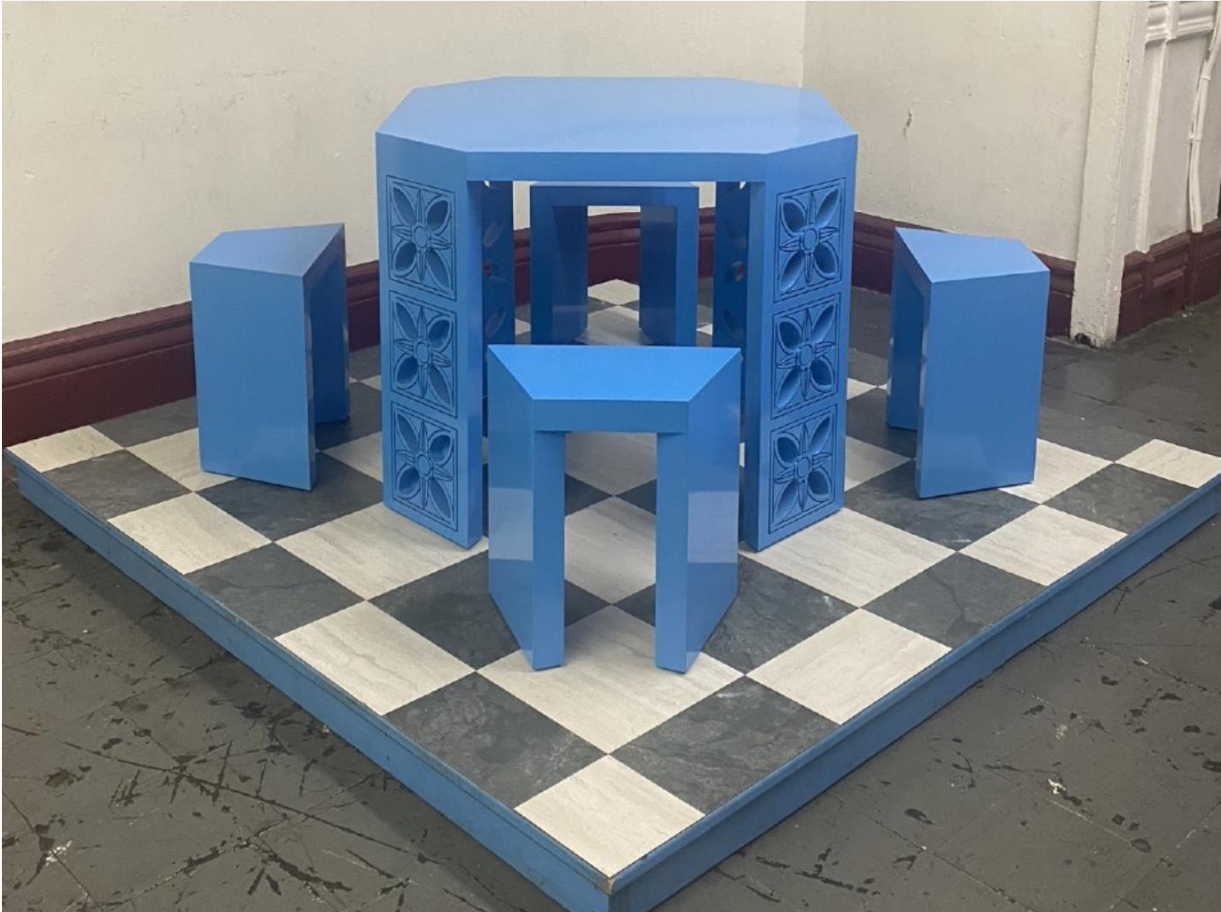

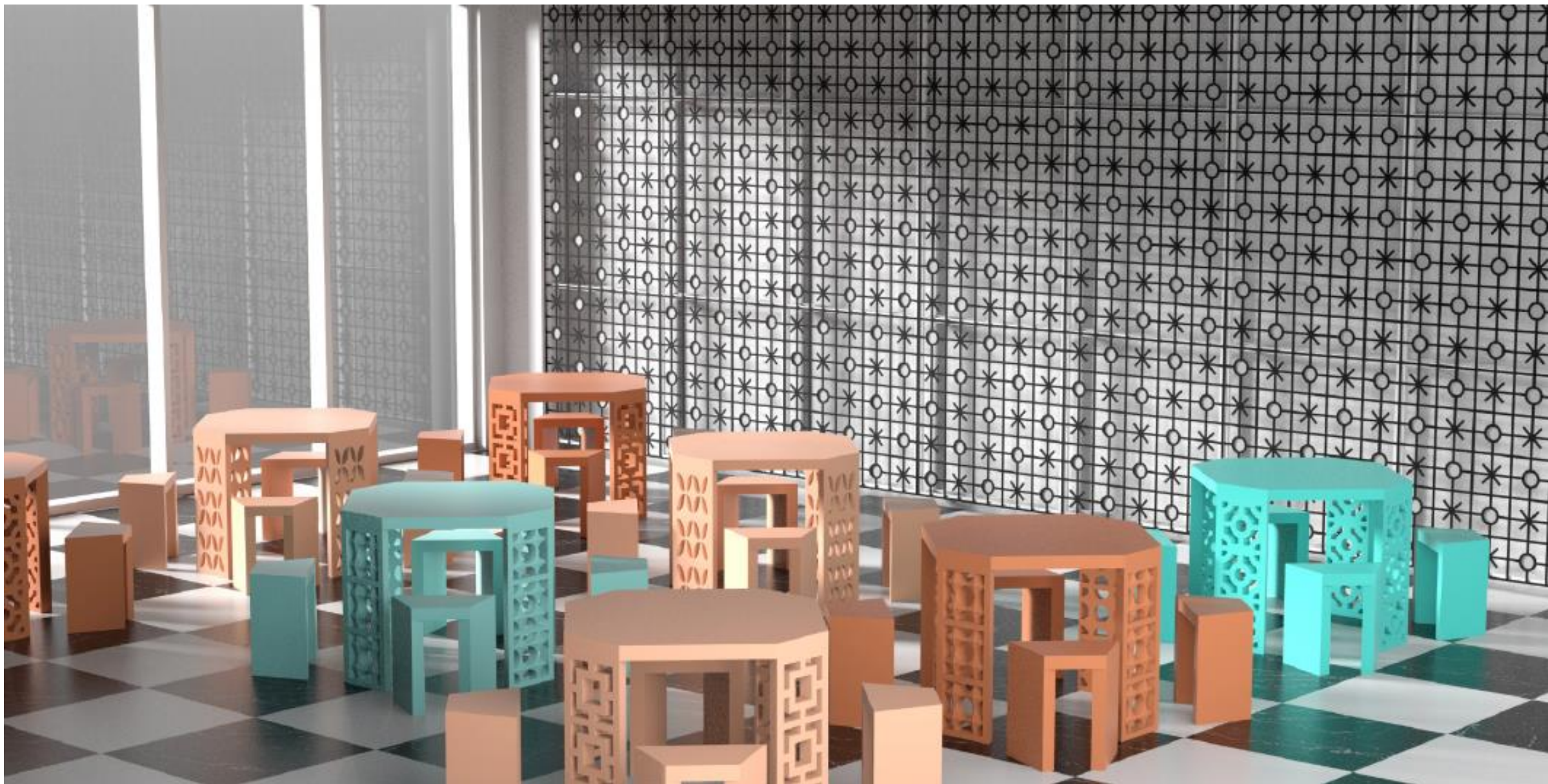

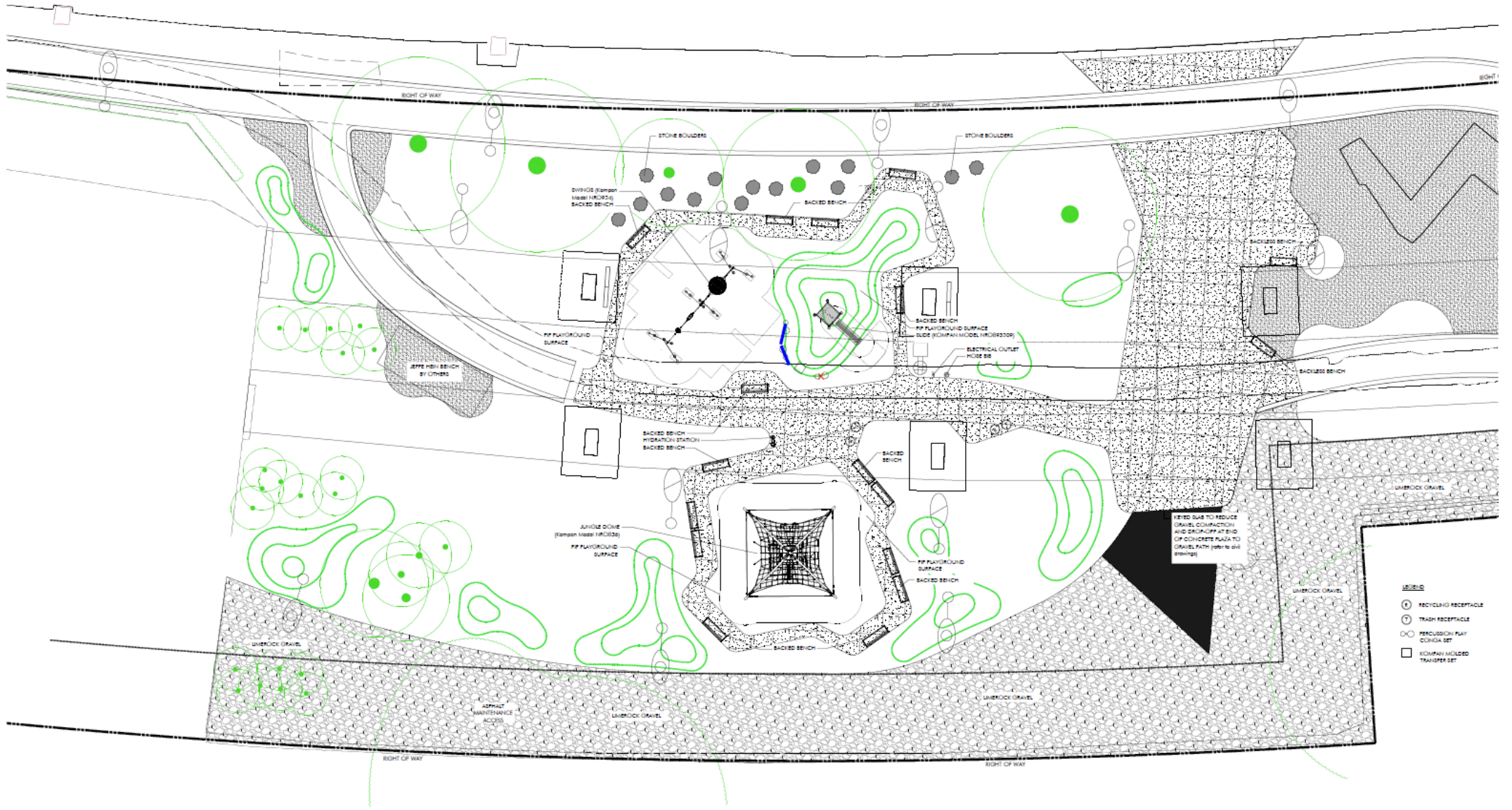
